

#### **Product description:**

JTA-2 is a rectangular exhaust hood for high air discharge. . It is constructed for embedding in the ceiling or roof structure. JTA-2 consists of a cone and damper part, along with a top plate. It features self-closing dampers and internal drainage with a nipple in Ø32mm dimension for connection to a water trap. There is also a nipple for connection to spiral duct at the bottom of the unit. Top plate dimensions can be customized upon request.

This EPD is created for JTA-2-Ø315, which is the most commonly used dimension for this product. If you desire values for other dimensions, please utilize the factors provided in the table under technical data.

#### Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

#### Allocation:

The allocation is made in accordance with the provisions of EN 15804. Energy, water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.


#### Data quality:

2. This impact category deals mainly with the eventual impact of low dose ionizing radiation on human health of the nuclear fuel cycle. It does not consider effects due to possible nuclear accidents, occupational exposure nor due to radioactive waste disposal in underground facilities. Potential ionizing radiation from the soil, from radon and from some construction materials is also not measured by this indicator.
